

# CORPORATE MEMBERSHIP:

Corporate Membership are limited to 100 members. Cost includes \$1,000 for corporate certificate. Dues are \$300 per month with a minimum spending on food and non alcoholic beverages of \$140 per quarter. Corporate member may hold office and have voting rights. This membership includes the primary member, their spouse, and any children and grandchildren 21 years of age and younger. Corporate members also receive free cart rentals for the primary members and their household.



# EXECUTIVE MEMBERSHIP:

The Inclusive Membership will have all the privileges of the club including unlimited cart fees for the primary member and their household, range fees included, lockers, & club storage fees included. This membership is still subject to Capital Fees. The initiation fee is \$500. Dues are \$325 per month with a \$140 food and non alcoholic beverage minimum. This membership covers the primary member, their spouse, and any children 21 years of age and under.



# ASSOCIATE MEMBERSHIP:

Associate Membership will have all privileges. (carts are not included) Non transferable. Initiation fees are waived. Dues are \$270 per month with a minimum spending on food and non alcoholic beverages of \$140 per quarter. Associates may pay an additional \$1050 to transfer up to a Corporate Membership. This membership covers the primary member, their spouse, and any children and grandchildren 21 years of age and under.





## INDIVIDUAL GOLFER MEMBERSHIP:

Individual Golfer Membership is specifically golf focused. You do not need to be "Single Status" to apply for this membership. This membership includes usage of all our facilities (carts not included), add the pool for an extra \$200 for the pool season. Dues are \$192 per month with a minimum spending on food and non alcoholic beverages of \$140 per quarter. This membership covers the golfing member only.

## JUNIOR MEMBERSHIP:

Eligibility for Junior Membership is restricted to those 34 and under. This membership can enjoy all the privileges of the club. (carts not included) . Initiation fees are waived. Dues are \$130 per month with a minimum spending on food and non alcoholic beverages of \$80 per quarter. This membership covers the primary member, their spouse & children under 21 year of age.

## SOCIAL MEMBERSHIP:

A Social Membership can enjoy Sherman's Restaurant and Bar, Pool & Social Events. Golfing is subject to tee time availability and guest fees. Initiation fees are waived. Dues are \$135 per month with a minimum spending amount of \$140 per quarter. This membership includes the primary member , their spouse, and any children and grandchildren under the age of 21.

## BUSINESS MEMBERSHIP:

The Golf Business Membership is ideal for the business looking for golf and dining privileges. The company is allotted 60 rounds of golf to distribute as they see fit. Cart use, a five day advance tee time reservation and complimentary range balls will be included with this membership. The costs include \$2,820 annual membership fee and a quarterly food and non alcoholic beverage minimum of \$140 per quarter. No initiation fee. The annual fee must be paid in full by the company. Unused rounds will expire one year from the date of the application.
